










MANUAL and AUTOMATIC tool change with NO NEED for electrical or pneumatic installations

The WINGMAN Tool Changer System is a mechanical tool changer system that activates the lock/unlock mechanism by means of the cobot's motion through space – Hence no electricity nor pneumatics must be installed to the WINGMAN Tool Changer for it to complete automatic tool changes.



- 1 Tool changer robot part (connects to the cobot)
- 2 Tool changer tool part (connects to the cobot tool)
- 2a Lever for locking and unlocking
- 3 Tool part holder (for automatic use stores the tool part(2))
- <u>Ba</u> Tool part holder installaton holes (fits metric std. alu profiles)
- 4 Pass-through module interface (in total, three module set's can be fitted)
- 5 Build in pneumatic pass-through interfaces (there are two for M5 fittings)
- 6 Tool flage (Std. ISO 9409-1-50-4-M6)





1 Important safety notes

2 Definitions

cobot	<i>Cobots,</i> or collaborative robots, are robots intended to interact with humans in a shared space or to work safely in close proximity. Cobots are usually also very easy and fast to setup and program.
collaborative applications	A <i>collaborative application</i> is a cobot application where the <i>cobot</i> is installed and deployed without a physical safety guard protecting humans.
collaborative operation	<i>Collaborative operation</i> is a state in which purposely designed <i>cobots</i> work in direct cooperation with a human within the defined workspace.
collaborative workspace	<i>Collaborative workspace</i> is the space within the safeguard space where a <i>cobot</i> and a human can perform tasks simultaneously during production operation.
Controller	A <i>controller</i> is an electrical devise with terminals for <i>I/O</i> 's and a computer logic between the Input(I) and the outputs(O). Usually a <i>cobot</i> is delivered with a <i>controller</i> . A controller can also be a separate control unit that provide control of pneumatic flow etc.
End-effector	An <i>end-effector</i> is a robot tool / service specially designed for attachment to a cobot's mechanical interface (<i>tool flange</i>) to enable the cobot to perform its task. Example: Gripper, nutrunner, welding gun, dispenser, screwdriver etc.
I/O's	"I" stands for Input and "O" stands for Output. <i>I/O</i> is a brad term covering all electrical Input and Output connectivity and control between a <i>controller</i> and an <i>end-effector</i> .
Installed Center of Gravity (ICoG)	The ICoG is the center of gravity for the tool part(WINGMAN Tool Changer part) and the end-effector assembly perceived as one body as this is installed in the tool part holder(WINGMAN Tool Changer part). The location of the tool part + end-effector body's ICoG will depend on the angle in which the tool part holder is installed.
System integrator	A System Integrator is a person or an entity who installs and deploys a robot application, such as a collaborative application. In case the end-user (person or entity) installs and deploys a robot application, the end-user will be the System Integrator and have the System Integrators' responsibilities among other to safety approve the application.
Pass-through connectivity Pass-through connections Pass-through modules	Pass-through connectivity are means (pass-through modules) that allow energy and control such electricity, pneumatic and vacuum to flow to/from the end-effector. Tool changers for automatic use will need to facilitate the necessary pass-through connectivity.
Robot limits	A cobot's <i>robot limits</i> is a set of threshold limits that will result in a <i>protective stop</i> of the cobot if exceeded. <i>Robot limits</i> can be but is not limited to threshold limits associated with: - Power limit. - Force limit. - Speed limit.
protective stop	A <i>protective stop</i> is a type of interruption of a <i>cobot's</i> operation that allows a cessation of motion for safeguarding purpose and which retains the program logic to facilitate a restart.



Quasi-static contact Transient contact	Quasi-static contact and transient contact are two types of potentially harmful (human injury) contact that are defined and handled in standard ISO/TS 15066:2016. Quasi-static contact is a human limb being pinching between a fixed object and a moving object such as a cobot. Transient contact is a human being hit by a moving object such as a cobot.
residual risk	<i>Residual risk</i> is the risk that remains after all planned risk reducing initiatives have been ensured. A <i>collaborative application</i> will have a residual risk that must be accepted by the <i>System Integrator</i> and the user before the <i>collaborative application</i> can be deployed.
teach-in	<i>Teach-in</i> is a feature that some <i>cobots</i> have and that allow the user to program the <i>cobot's</i> motion in a simple way by moving the <i>cobot</i> to <i>waypoints</i> by hand.
teach pendant	A cobot <i>teach pendant</i> is a computerized control panel that allows a user to set up and program the cobot. A <i>teach pendant</i> is usually connected to the cobot wia a cable.
tool changer system	A <i>tool changer system</i> is a complete system of parts, that allow a user to complete manual or automatic tool changes in a quick and easy way.
tool space	The <i>tool space</i> is a space surrounding the rack that stores the <i>end-effectors</i> when these are not attached to the cobot. The <i>tool space</i> is safeguarded by <i>robot limits</i> only. As the user is NOT allowed to access the <i>tool space</i> while the cobot is in operation, the <i>tool space</i> cannot be perceived as part of the <i>collaborative workspace</i> .
URcap software	An URcap software is a piece of software that can be use with Universal Robots (UR) only and provides an intuitive graphic user interface (GUI) that runs directly on the UR <i>teach</i> pendant in the original UR software named Polyscope.
Waypoint	A <i>waypoint</i> is a X, Y, Z coordinate and RX, RY, RZ rotation of a <i>cobot's tool flange</i> in space. A <i>cobot</i> moves between such <i>waypoints</i> .



4 Unboxing your kit

4.1 Manuel kits

The **manual kit** enables you to complete quick and easy **manual** exchange between cobot tools and is provided with all the necessary parts for installation on a cobot that is featured with the ISO 9409-1-50-4-M6 tool flange like cobots from Universal Robots, Techman robots and other.

The manual kit is featured with pneumatic *pass-through connections* built into the housing. If additional *pass-through connectivity* is needed, pass-thought modules are available for purchase. See available pass-through modules in chapter **Product data** in the end of this user guide.





4.2 Automatic kits

The **automatic kits** enable you to complete quick and easy **manual and automatic** exchange between cobot tools and is provided with all the necessary parts for installation on a cobot that is featured with the ISO 9409-1-50-4-M6 tool flange like on cobots from Universal Robots, Techman robots and other.

The kits are featured with pneumatic *pass-through connections* build into the housing and can be included with additional modules for electricity and for pneumatic/vacuum pass-through. See available **automatic kits** and pass-through modules in chapter **Product data** in the end of this user guide.







5 Intended use

The WINGMAN Tool Changer System is intended for industrial use with collaborative robots from Universal Robots and other cobot brands. The WINGMAN Tool Changer System is intended for easy exchange between *end-effectors* either manually by the user or automatic by the cobot it is installed onto.

The WINGMAN Tool Changer System can be deployed in combination with collaborative robots (cobots) for use in *collaborative operation* when all requirements in this user guide have been complied with.

Any kind of use that deviates from the intended use described in this user guide is misuse and is not allowed. This includes but is not limited to:

- Use in explosive environments, offshore installations and aircraft operation.
- Use in medical and food production lines or in combination with vital equipment.
- Use before a full risk assessment has been performed to local legislation/standards by the *system integrator*.
- Use as lifting equipment on cranes.
- Use outside of declared specifications and parameters.
- Use close to a human's head, face and eye area.
- Use before all requirements in this user guide have been complied with and residual risks are understood and accepted.





6 Installation

6.1 Installation environment, specifications and safety

A stress free and clean environment surrounding the work area will promote safety and long product life span. Please read chapter **9 Safety** for information on safety before commencing the installation and read chapter **10 Repairs and maintenance** for information on the topic of life span.

6.2 Pre-installation preparation

The tool changers *maximum allowed payload* must be evaluated using the equations or graphs provided in the tool changer datasheet chapter **Data sheet – TOOL CHANGER**.

Investigate if the *end-effector(s)* you plan to deploy is suitable for automatic tool change applications. If in doubt, please ask the *end-effector* vendor.



TIP! A few electrical *end-effectors* are installed with a failsafe feature that will stop the robot program if the *end-effector* is disconnect from the cobot while the robot program is running. Ask your *end-effector* vendor how to bypass this failsafe feature.



WARNING! Deploying the WINGMAN Tool Changer System outside the framework of intended use and technical specifications such as *maximum allowed payload* can result in hardware damage, serious injury and even death.

6.3 Installing the robot part

The *robot part* fits directly onto *cobots* from Universal Robot and other cobots with a standard *ISO 9409-1-50-4-M6* flange. If your *cobot* does not have this flange, you can install an adaptor flange in between (not provided by TripleA robotics).

Step 1. Install the pin in the *robot part*.



Step 2. Install the *robot part* on the *cobot* using all four provided bolts (ISO 10642 M6x12mm). Tighten all four bolts with the torque specified for your *cobot*.







TIP for Universal Robots! In the UR-cap software provided by TripleA robotics, you can adjust the orientation of how the robot part is installed on the UR cobot. If you have used the pin as per step 1, no adjustment of the orientation is needed.

Step 3.

Install the pass-through modules you need for your application if any and install the necessary cables/hoses between your chosen controller and the pass-through modules. See chapter 6.5 Installing pass-through modules to learn about pass-through modules.





ATTENTION! It is important that all cables/hoses are fixed securely to the cobot arm and cannot be caught and damaged while the cobot moves.





6.4 Installing the *tool part*

You can fit the tool part on most cobot end-effectors that have the standard ISO 9409-1-50-4-M6 flange. If your cobot end-effector does not have this flange, you can install an adaptor flange in between (not provided by TripleA robotics).

Install your end-effector on the tool part using the bolts provided with your end-effector and tighten the Step 1. bolts as per instructed in the end-effector documentation (maximum 8 Nm).





ATTENTION! Do not install bolts that protrudes more than maximum 7 mm into the tool part. If too long bolts are attempted installed, the tool part can be damage beyond repair.



Step 2. Install the pass-through modules onto the tool part that mates with the pass-through modules you installed onto the robot part. See chapter 6.5 Installing pass-through modules to learn about pass-through modules. Make sure to locate the pass-through modules in the correct place to mate correctly with the counterpart pass-through module on the robot part. Install your end-effector's cables/hoses to the passthrough module.





TIP! If a pass-through module and/or cable cannot be installed because the end-effector is taking up too much space, you can install a 30 mm distance adaptor between the end-effector and the tool part (not provided by TripleA robotics).



ATTENTION! Locating pass-through modules incorrectly can result in hardware damage.

Step 3. Attach and lock the robot part and the tool part to each other (see chapter 7 MANUAL USE) and test all the end-effector's functions on the cobot in a controlled test environment before starting programming and deployment into production.




WARNING! Connecting and disconnecting an end-effector from its source of energy and control can in some cases pose a risk to human health if the end-effector reacts unintentionally/unpredictably. Therefor make sure that energy and control is turned off before connection/disconnecting end-effectors.



6.5 Installing pass-through modules

Pass-through modules are installed and uninstalling **WITHOUT** use of tools simple by "clicking" them into place. The pass-through modules are a tight fit and requires you to wiggle carefully with the modules to install and uninstall while applying even pressure on the module as close to the *tool part / robot part* as possible.



The pass-through modules for the *robot part* will **ONLY** fit to the *robot part* and pass-through modules for the *tool part* will **ONLY** fit to the *tool part*. The **blue** and **orange** dots guide's for correct fit.



The pass-through modules are correctly installed when they align with the *tool part / robot part* surface.



ATTENTION! Never use tools of any kind to install or uninstall a pass-through module and never try to force a pass-through module into place or out of place.

ATTENTION! Never touch delicate parts of pass-through modules such as electrical terminals etc. as these can get damaged easily.

ATTENTION! A little silicone-based grease must be applied on all rubber parts such as O-rings and gaskets, on the pass-through modules to ensure long lift span and prevent leaks.



WARNING! Do not install a pass-through module on the *robot part* without also installing the matching pass-through modules on **ALL** the *tool parts* you deploy. If you are not using a pass-through module located on a *tool part*, install the provided plug on the connector(s) of the pass-through module. Failing in doing so will result in the cobot performing its tasks with exposed open connectors (electrical, pneumatic etc.) which can result in hardware damage and injury.

WARNING! Always ensure before deployment that *end-effectors* are provided with the correct type and level of energy/control that they are intended for. An *end-effectors* provided with incorrect energy/control



can pose a risk of hardware damage and injury. The *pass-through modules* **do not** provide protecting against such errors and injury.


WARNING! Do not use the *pass-through modules* outside their specifications and **NEVER** use the electrical *pass-through modules* for voltage level that can be harmful for humans such as 110/220 volts.

WARNING Energy (electricity, vacuum, air pressure) to a pass-through module must be turned off and any residual electricity, air pressure, vacuum etc. in the system must be eliminated before tool change takes place. Failing in doing so will result in hardware damage (e.g. damage to electrical connectors) and can result in injury.



6.6 Installing the *tool part holder*

The *tool part holder* supports an end-effector of up to 5 kg installed in the *tool part holder* with a center of gravity that results in up to 1 Nm of torque (*rated couple payload*). It has two elongated holes intended for 6 mm bolts for installation. The two mounting holes makes installation easy on a tabletop or on standard aluminum profiles such as: 50*100 mm / 50*50 mm / 40*80 mm / 40*40 mm.





TIP! Tool change with heavier tools then 5 kg is possible but will require a custom made solution to support the tool weight as coupling and decoupling takes place, to ensure that the weight on the *tool part holder* does not exceed the *tool part holder's* rated payload.



- Step 1. Find a sturdy surface in reach of the *cobot* and suitable for installing the *tool part holder* onto. A suitable place will be:
 - a. on the same sturdy structure that the *cobot* is installed onto or an equal sturdy surface with a fixed position relative to the *cobot*.
 - b. in a position, that will allow the *cobot's* collaborative safety settings (*robot limits*) to work as intended (consult your *cobot's* user guide).



WARNING! Always ensure that you install the *tool part holder* in a place where your cobot's collaborative safety settings (*robot limits*) will work as intended as the *cobot* moves in proximity of the *tool part holder*. Failing to ensure that your cobot's *robot limits* works as intended can cause serious injury and even death.

- c. in a position, that allow the cobot to have a relatively rigid posture as it performs movements associated with tool change.
- d. in a position, that will allow for an *Installation Center of Gravity* (ICoG) to be as close to the center of the *tool part* as possible. See details about ICoG in **step 2**.
- e. in a position that will allow for safe passage of the *end-effector* moved by the *cobot* to and from the *tool space* (see chapter 9.5 The Tool Space).
- f. in a position that will allow for safe and clean keeping of the *tool space* (no metal chips flying around etc.)
- g. In a position that will allow fluids e.g. from CNC machinery to run off the end-effector and tool changer parts without causing hardware damage such as damage to electrical parts.
- h. in a position where all deployed *tool part holders* preferable can be placed close to each other and close to the working area so that the *cobot's* movement is minimal when exchanging between *end-effectors.*
- i. In a position where an *end-effectors* fall from a *tool part holder* cannot cause unacceptable hardware damage or injury to a user or a spectator.
- j. In a position that preferable is out of reach for users and spectators and in general promote safety with considerations to:
 - i. users not having routine tasks in the immediate proximity and
 - ii. where users and spectators are unlikely to put their limps by accident, coincidence or by convenience and
 - iii. where users/spectators head/face does not risk contact with the *tool part holder(s)*.



WARNING! Users and spectators are NOT allowed to move limbs into the *tool space* as a robot program is executing. Even though all safety instructions in this user guide are followed, a user or spectator risk injury if limbs are moved into the *tool space* as the robot program is executing.



Step 2. Decide on the installation orientation of the *tool part holder*. To ensure smooth tool change and long life span, the *Installed Center of Gravity* (ICoG), must be as close to center of the *tool part* as possible. The ICoG is the center of gravity of the assembled *tool part* and *end-effector* body as this body is located in the *tool part holder*. In case an ideal ICoG (marked with a red dot in beneath illustrations) cannot be achieved, the ICoG must be placed in the direction marked with green in beneath illustrations and with a torque between the *tool part holder* and *tool part* of maximum 1 Nm e.g. maximum 1 kg placed maximum 100mm in the green area. If torque is high, it is recommended to place the ICoG to the side. Lubrication of the *tool part holder* will be necessary as ICoG is offset from center.

TIP! If your end-effector is heavy (from 1 kg to 5 kg), orientation no. 4 or 5 will usually be the best choice to ensure the best ICoG, smooth tool change and the longest life span while orientation no. 3 in most cases will be the best choice in moist environments.



WARNING! The end-effector can fall from the tool part holder if the cobot or the user unintentionally pushes it out of the tool part holder. If an end-effector's fall from the tool part holder poses an unacceptable risk of injury or hardware damage, the end-effector in question should not be used in combination with the WINGMAN Tool Changer System.

WARNING! Never install the tool part holder in a way so gravity can cause the tool part to fall out of the tool part holder.

Step 3. Install the tool part holder by using the supplied M6 wing screws and tighten firmly with your fingers to prevent the tool part holder to move as tool change takes place.





WARNING! Never install the tool part holder without using the supplied wing bolts which are there for safety reasons. In case the cobot stops with a person being caught between the cobot arm and the tool part holder, the wing screws are there to ensure that the person can escape by uninstalling the wing screws.



7 Manual use



WARNING! Before engage/disengage the tool changer's robot part and tool part, make sure that all energy and control to the end-effector has been turned off. Failing in doing so can cause serious injury and even death.

Locking and unlocking 7.1

Step 1. Unlocked: Move both levers on the tool part (one on each side) with your fingers to the unlocked position where the red markers on the *levers* are visible, and the green markers are not visible.



(Only one lever is shown in above illustration)

Step 2. Pre-locked: Engage the tool part with the robot part and PRESS on both levers with your fingers so that they move to the *pre-lock position* where the **red** marker and the **green** marker are both visible on both levers.

WARNING! It is not allowed to deploy the tool changer when in pre-locked position as the tool changer will not have full strength.


Locked: PRESS again on both levers with your fingers to the locked position where only the green markers are visible, and you feel a "click" as the levers move into place.

ATTENTION! Do not use tools of any kind such as screw drivers etc. to move the levers as this will permanently damage the levers.

8 Automatic use



WARNING! You must read, understand and fully comply with all the requirements in chapter **9 Safety** before commencing cobot motion.

DANGE

WARNING! Before you start programming and testing automatic tool changes, you must ensure to do it in a safe way. Failing in doing so can cause hardware damage, injury and even death. Among other you must:


- adjust the cobot's robot limits (collaborative safety limits) to a setting that correspond your risk assessment,
- adjust the cobot's speed to a low setting that allow you time to move free from moving parts,
- prevent unintended/unexpected movement of the cobot and of the end-effector(s),
- prevent incorrect energy levels to reach the *end-effector* (e.g. 24 volts to an *end-effector* designed for 12 volts) and
- ensure that the *end-effectors* you plan to deploy are suitable for automatic tool change.

WARNING! The cobot retrieving an incorrect/unintended *end-effector* poses a risk of hardware damage, injury and even death.

- When setting up an *end-effector*, you must always pair the *end-effector* with its designated *Tool part holder* by applying corresponding ID tags on both parts (not provided by TripleA robotics).
- In your Robot Program, you must always use a corresponding ID tag for your GET TOOL and PUT TOOL commands for that particular *end-effector*.
- When deploying a new robot application or redeploying and existing robot application, you must always test the Robot Program at slow speed and in a controlled test environment to confirm that *end-effectors* are located correctly and everything executes safely and as intended.

The WINGMAN Tool Changer System is a mechanical tool changer system that activates the lock/unlock mechanism by means of the cobot's motion through space – Hence, there is no need for electricity nor pneumatic installations to achieve automatic tool changes.

The cobot's motion through space executes tool changes via four mandatory *waypoints* (W1, W2, W3 and W4).



The mechanisms patented construction allows for inaccurate programming of *waypoints* however, accurate *waypoints* will ensure smooth tool changes and long life span.

Waypoint **W2** is the reference point for W1, W3 and W4 and is the cobot's position when the *robot part*, the *tool part* and the *tool part holder* are all fully engaged with each other.







TIP! There are two build in pneumatic pass-through connections and three pass-through module interfaces available which allows you to exchange between four end-effectors that all use different sources of energy/control and an infinite number of end-effectors that share the same source of energy/control.



INFO / TIP

TIP for Universal Robots! With use of the URcap software provided by TripleA robotics, you will only have to teach W2. The remaining mandatory waypoints (W1, W3 and W4) are calculated automatically.

ATTENTION! It is important that the *cobot* moves between waypoint W1 and W4 in **linear motion** with a maximum radius of 0,5 mm between change in direction.



ATTENTION! Even if the *tool space* is inaccessible for the user, e.g. behind safety guards, the *robot limits* that ensure collaborative safety must always be setup as per instructed in chapter 9 safety to prevent overload and damage to the levers in the *tool part*. The levers are designed to break in case of overload.

8.2 Important about cobot speed

Among other, the cobot's speed must be considered in the Integrator's mandatory risk assessment.



ATTENTION! High tool change speed will increase wear and increase risk of hardware damage. If the tool change emits significant noise, the speed should be reduced, and the **11** Troubleshooting chapter should be consulted. The levers are designed to break in case of the excessive force.

WARNING! For safe *collaborative operation* and long life span, the cobot's speed must be considered to ensure that a user/spectator has time to predict the cobots movement and has time to move limbs away to avoid quasi-static contact between moving and fixed bodies being part of the tool change process. The cobot's speed must also be considered to avoid quasi-static pressure being able to build up to an unacceptable level in case a person's limb is not moved in time.

8.3 Important about end-effector parameters

As a tool change takes place from one *end-effector* to another, the cobot needs to toggle parameters like voltage, pneumatic and vacuum ON/OFF. Before tool change takes place all electrical, pneumatic and vacuum must be turned OFF and with no residual electricity, air pressure, vacuum etc. in the system.




WARNING! Providing an *end-effector* with incorrect energy/control can cause hardware damage, injury and even death. If you are in doubt of what parameters to use for your *end-effector*, you must consult the *end-effector's* technical documentation or contact the *end-effector* supplier. Tool change between *end-effectors* must always be thoroughly tested before deployed into production.

8.4 Good practice for setting up tool changes

When setting up automatic tool change, good practice will reduce risk of hardware damage and injury.

- Step 1. Install the *end-effector* you intend to deploy onto the cobot by follow the instructions provided in chapter **6** Installation.
- Step 2. Determine, test and note down the parameters necessary for the *end-effector* to work properly such as:
 - Tool Center Point (TCP).
 - Payload.
 - Center of Gravity (COG).
 - Tool voltage.
 - Tool IO setup.
- Step 3. Uninstalling all *pass-through modules* on the *robot part* and on the *tool part* and move the *end-effector/tool part* assembly to the designated *tool part holder*.





WARNING! To reduce risk of hardware damage and human injury, always test tool changes thoroughly, at low cobot speed and in a controlled and safe test environment.

WARNING! Programming the cobot movement without the *pass-through modules* installed is important to prevent hardware damage and injury.

- Step 5. Install the *pass-through modules* and means for connectivity and program/test the *end-effector's* functionality in conjunction with the automatic tool change movement as per instructed in chapter **8.5.4** Basic setup of end-effector parameters and chapter **8.5.7** Advanced setup of end-effector parameters.
- Step 6.

6. Now test the full tool change process thoroughly to ensure that tool changes are executed with a high level of reliability/stability.



WARNING! Failing to test the full tool change process thoroughly and ensure reliability before deploying into production will increase risks significantly as a user might feel tempted to intervein in a running process, which is **NOT** allowed and can cause injury.

Step 7. Follow step 1 through 6 for all other *end-effectors* you plan to deploy and finalize your Robot Program.

8.5 Programming tool change on Universal Robots cobots

The URcap software from TripleA robotics provides easy and fast programming of tool changes on cobots from Universal Robots in few minutes. The URcap software is compatible with:

- **CB3 series** Polyscope version 3.13 or later and
- e-series Polyscope version 5.8 or later.

To prevent conflicts with third party URcap software installed on your cobot, the URcap software from TripleA robotics is passive with no "threads" running in the background. The URcap simply helps you build perfect tool change programs easy and fast.

The PolyScope screenshots used in this user guide are based on e-series URsoftware version 5.8. The CB3 series will look very different but will have the same functionality.



ATTENTION! The required *robot limits* explained in chapter **9 Safety** must be setup not only for safety reasons but also to limit the cobot's strength to prevent damage to the levers in the tool changer.



WARNING! You must read, understand and fully comply with all the requirements in chapter **9 Safety** before commencing cobot motion. Failing in doing so can cause serious injury and even death.



WARNING! Programming automatic tool change must always be conducted as per instructed in chapter **8.4 Good practice for setting up tool changes**.




8.5.1 Preparation

- Step 1. Update your Polyscope to the latest version.
- Step 2. Install the URcap software from the USB stick provided by TripleA robotics.

8.5.2 How the URcap software works

The URcap automatically generates the tool change program trees for you. The autogenerated program trees will including control of waypoints, payloads, COGs, TCPs and Tool I/O's for each *end-effector* you deploy. The URcap allows you to add the following three types of nodes to your Robot Program.

• AAA - Tools: This is the first node you will add to your Robot Program. The AAA – Tools node will hold tool change parameters for all your *end-effectors* like a database. Only one AAA – Tools node is allowed in your Robot Program.




• **AAA – Get Tool:** Add this node to your Robot Program when you want the cobot to collect a specific *end-effector* from its designated *tool part holder*.

• **AAA Put Tool:** Add this node to your Robot Program when you want the cobot to return a specific tool to its designated *tool part holder*.



Adjustments to a tool change setup is done in the **AAA** – **Tools** node. If you make adjustments to a tool that has a **AAA** – **Get Tool** or a **AAA** Put **Tool** node assigned in the program tree, these nodes will become inactive (yellow) until you have visited the nodes and >recreated< them.



TIP! Some third-party URcaps runs threats in the background that overwrites the *active TCP*. Third-party URcpas might also change other parameters in ways that can be difficult to predict. In case the cobot moves in an un-logical/unintended way, this is most likely caused by a third-party URcap running a thread in the background. To find out, uninstall third-party URcaps one by one and test.






WARNING! The URcap software provided by TripleA robotics does **NOT** provide the mandatory collaborative safety settings, the *robot limits*. Instead these must be setup manually before it is allowed to deploy cobot motion. Details are provided in chapter 9.7 Load limiting and collaborative safety settings

8.5.3 Basic setup of tool change movement


Step 1. Start a new Robot Program and navigating to *URCaps* > **AAA** – **Tools** to add a **AAA** – **Tools** node to your Robot Program. If a popup appears, confirm to create the node.






TIP! The popup makes sure that there is only <u>one</u> active **AAA** – **Tools** node in your Robot Program. Creating a second **AAA** – **Tools** node will overwrite the first **AAA** – **Tools** node. The **AAA** – **tools** node that is superseded will be labeled *"Delete Me"* and must be deleted manually before the Robot Program can execute.

Step 2. Create you first *end-effector(Tool)* by navigating to *Robot Program > AAA – Tools* and press the *>Create Tool<* button. This will autogenerate the *Tool: T1* program tree which holds all your settings for your *end-effector* called *"T1"*.



- Step 3. Navigate to the *Robot Program > AAA Tools > Tool: T1* and change the *>Name<* to correspond to your *end-effector's* ID tag (In this user guide we keep the "T1" ID tag). See chapter 9.9 ID Tag system.
- Step 4. Navigate to the Robot Program > AAA Tools > Tool: T1 > Config > Tool Holder Pos.(W2) and press the >Teach Holder Position< button to teach waypoint W2 for the end-effector location. See more about waypoint W2 in chapter 8.1 Important about waypoints.</p>



After teaching waypoint W2, all other waypoints necessary for tool change are calculated automatically by the URcap software. You are now done setting up the basic tool change movement.

Step 5. Prepare a tool change test by navigating to URCaps > AAA – Get Tool and place a AAA – Get Tool node in the end of your Robot Program.

Now navigating to *URCaps* > *AAA* – *Put Tool* node and place a **AAA** – *Put Tool* node in the end of your Robot Program. In both nodes, choose the *end-effector's* ID tag name(T1) from the dropdown and press the *>Create/Recreate<* button.

Step 6. Remove all *end-effector(s)* hardware from the robot application, stand clear of the cobot and run the Robot Program at very low speed and observe if the tool change movement looks as expected.

TIP! A common cause of error is if the *robot part* is not installed onto to cobot's *tool flange* in its standard orientation using the 6 mm positioning pin. If the *robot part* cannot be installed in its standard orientation, please see solution in chapter **8.5.8 Odd orientation of the robot part on the cobot's tool flange**. In case of other issues, please refer to chapter **11 Troubleshooting**.

Step 7. If the cobot's movement looks ok, stop the program and place the *end-effector* hardware in the *tool part holder* and run the program again to observe the actual tool change taking place. Test the cobot movement **without** the pass-through modules installed to reduce the risk of hardware damage.



TIP! To test **AAA – Get Tool** nodes and **AAA – Put Tool** nodes individually in a flexible way, see the guide in chapter **8.5.5** Powerful TEST feature and good programming practice.



8.5.4 Basic setup of end-effector parameters

After you have tested thoroughly that tool change movement executes correctly, it is time to install, setup and test the *end-effector* connectivity and functionality.

Step 1. To set up your *end-effector's* TCP, payload and COG, navigate to *Robot Program > AAA – Tools > Tool: T1 > Config > Tool TCP* and type in the parameters for your *end-effector*.

TIP! As an **AAA** – **Get Tool** node is run, it will set the tool' s TCP using URscript. This has the disadvantage that when you test parts of your Robot Program and not initiate your test with calling the **AAA** – **Get Tool** node for the tool you are using, then the TCP is be set incorrectly to the default PolyScope TCP setting from the installation tap.

It is therefore recommended only to use the *Payload and Center of Gravity* settings (Payload, CX, CY and CZ) and **not** the *Tool Center Point* settings X, Y, Z, RX, RY and RZ settings. Instead leave the *Tool Center Point* settings at zero and create a new tool and setup it up in the *Installation > TCP* menu. In your Robot Program's *MoveL/MoveP* nodes select the tool you are using in the *Set TCP* drop down menu. Make sure you have the correct tool selected in the *Installation > TCP* menu when you teach in your Robot Program.


Step 2. If you are deploying an electrical *end-effector* connected to the cobot's Tool I/O's available at the cobot's tool flange, you can put in your *end-effectors* parameters in the **Tool I/O** setup found in the Robot Program > AAA – Tools > Tool: T1 > Config > Tool I/O node. The UR-cap will automatically turn off/on the voltage as tool change takes place to prevent damage to the electrical connectors.



WARNING Energy (electricity, vacuum, air pressure) to a pass-through module must be turned off and any residual electricity, air pressure, vacuum etc. in the system must be eliminated before tool change takes place. Failing in doing so will result in hardware damage (damage to electrical connectors etc.) and can result in injury.

If you are deploying an end-effector that is using other I/O's then the cobot's Tool I/O's available at the cobot's tool flange or if you need more control over the cobot's Tool I/O's, please see chapter 8.5.7 Advanced setup of end-effector setting.



ATTENTION! Be aware that when you test your Robot Program with a tool already located on the robot, the voltage is automatically set to the default setting found in the INSTALLATION>TOOL I/O if the relevant AAA-GET TOOL node is not run first to collect the tool and set the correct voltage. As you program and test your programming for a particular tool, the voltage in the INSTALLATION>TOOL I/O can be set to the correct voltage for this particular tool to avoid the voltage resetting each time you test your Robot Program without first calling the relevant **AAA-GET TOOL** node.

To avoid the risk of incorrect voltage to a tool, the voltage in the INSTALLATION>TOOL I/O should be set to OV, when you have finished the Robot Program for this particular tool.



Step 3. Navigate to the *Robot Program* > **AAA** – **Get T1** node and the *Robot Program* > **AAA** – **Put T1** node and press the >*Create/Recreate*< button for the Tool I/O settings you completed in step 2 to have effect.

WARNING! To reduce risk of hardware damage and human injury, always test tool changes thoroughly at low cobot speed and in a controlled and safe test environment.

8.5.5 Powerful TEST feature and good programming practice

Making use of SubPrograms in your Robot Program is good practice and provide you with several benefits:

- Keeping all the AAA Get Tool and AAA Put Tool nodes program trees collapsed at all times.
- Accomplish only one **AAA Get Tool** and one **AAA Put Tool** node for each *end-effector*.
- Making a simple yet powerful TEST node to run a single **AAA Put Tool** or **AAA Get Tool** node.

8.5.5.1 Deploy SubPrograms

Step 1. Navigate to the Robot Program and press the *>SubProg<* button in the advanced menu. This will create an empty SubProgram in the end of your Robot Program.



8.5.5.2 Powerful TEST node

You can use the method described in this chapter to run a **AAA – Get T1** or a **AAA – Put T1** node one time. This is helpful when you want to:

- 1. test a GET or a PUT command individually or
- 2. when you want to have the cobot retrieve an end-effector or put an end-effector back or
- 3. when you want to redeploy an existing Robot Program and you want to make sure, that all *end*-*effectors* are placed in their designated *tool part holders* simply by letting the cobot move each *end-effector* to its *tool part holder* one by one.
- Step 1. Follow the steps in chapter 9.5.5.1 Deploy SubPrograms to put your AAA Get T1 or a AAA Put T1 nodes in a SubPrograms.
- Step 2. Create a *Folder* in top of your Robot Program and rename the folder "AAA TEST". Put a *Call* function and a *Halt* function beneath it inside the folder.
- Step 3. Now visit the *Call* function and choose the SubProgram you want run/test from the dropdown.




- Step 4. Now run the Robot Program. It will run the SubProgram you have chosen one time only and the terminate.
- Step 5. When you have finished testing, simply make the folder inactive by pressing the icon in the bottom corner of the Robot Program tree. With that, the Robot Program will execute the full Robot Program and ignore your **AAA TEST** node.

8.5.6 Advanced setup of tool change movement

Waypoint W1, W3 and W4 are based on W2 and are calculated from a set of default values. These default values can be adjusted and additional two optional waypoints (waypoint W0 and W5) can be added.



Waypoint W0 and W5 is optional to allow you free passage waypoints to and from the *tool space*. See details about the *tool space* in chapter 9.5 The tool space and see details about waypoints in chapter 8.1 Important about waypoints.



WARNING! It is the *system integrators* risk assessment that determines how the cobot can move safely to and from the *tool space* among other at what speed the cobot is allowed to move. Be aware that the optional waypoint W0 and W5 uses the cobots default speed which might be too fast to ensure collaborative safety in your robot application.

Do the same for (Unset) Exit Part Pos. (W5)

8.5.6.1 How do deploy the optional waypoints:

Step 1. Navigate to the *Robot Program > AAA – Tools > Tool: T1 > Config > Tool Holder Pos.(W2) > (Unset) Enter Part Pos. (W0)* and press the *>Teach Enter Position<*. Now teach the position that ensures free passage to/from the *tool space*.



- Step 2. Navigate to the **AAA Get T1** and the **AAA Put T1** notes for the *end-effector* named "T1" and press the >*Create/Recreate<* button for your adjustments to have effect.
- Step 3. Set the cobots speed to a VERY low setting(!) and then test.

The mandatory waypoints W1, W3 and W4 can be adjusted if necessary.

If you need to change waypoint *Tool Holder Pos.*(*W2*), you can do so be teaching in this waypoint again. Doing so will have influence on waypoint W1, W3 and W4.

The cobot's speed between W1 and W4 has a default speed at 20 mm/s. This speed can be adjusted by navigating to the *Robot Program* > AAA – Tools > Tool: T1 > Config > Tool Holder Pos.(W2) node.




WARNING! Do not increase the cobot's speed between W1 and W4 beyond the speed that the *system integrator's* risk assessment permits. Also be aware that high tool change speeds may result in your product wearing out faster.

8.5.7 Advanced setup of end-effector setting

In some cases, you will need to setup special I/O configurations to get your *end-effector* to work properly e.g. if your *end-effector* makes used of Analog Tool I/O's or other I/O's than the Tool I/O's available at the cobot *tool flange*.

You can create a SubProgram that holds your *end-effector's* settings and call the SubProgram from the WINGMAN URcap software. The SubProgram can be called:

- at waypoint W1 where the *robot part* and *tool part* are separated from each other and
- at waypoint W4 where the *robot part* and *tool part* are locked to each other.



Your SubProgram can hold anything from a simple standard "SET" node, where you can configure all available I/O's, to you own bespoke complex UR script code. Calling a subprogram from the WINGMAN

URcap will always overrule the URcap's standard *end-effector* settings in case of duplication. This allows you to have full control and flexibility even in very advanced tool change applications.

Step 1. Add a SubProgram to your Robot Program and rename it "Get_T1_W4".

- Step 4. Navigate to the **AAA Get T1** node and press the *>Create/Recreate<* button for your change to have effect (found inside the subprogram **Get_T1** in the example illustration).
- Step 5. Run your Robot Program to test that the popup appears as the cobot reaches waypoint W4.

8.5.8 Odd orientation of the robot part on the cobot's tool flange

If the *robot part* is installed in an odd orientation (not directly onto the cobots *tool flange* or positioned without use of the 6 mm positioning pin, you will need to do a minor adjustment in the WINGMAN URcap software to compensate.

Step 1. Navigate to *Robot Program > AAA – Tools > Tool: T1 > Config > Tool Holder Pos.(W2)* and change the settings in the RX, RY, RZ fields (default 0 degrees) to match the orientation of the *robot part* on the cobot.

TIP! If you have installed the *robot part* on a Y-mount that adds weight to the cobot arm, it might be necessary to change the *Payload* and *COG* settings for the Tool Changer in the settings below the orientation settings. The *Payload* and *COG* settings in this view will apply after the Robot Program has executed a **AAA – Put T1** node hence where there is no *end-effector* on the cobot.

INFO / HP

Step 2. Now press the *>Teach Holder Position<* button and teach in waypoint *W2* to use the new orientation settings you have typed in in step 1.

Step 3. Repeat step 1 and step 2 for all your *end-effectors* for which the odd *robot part* orientation is relevant.



TIP! In case you have installed two *robot parts* on the cobot, e.g. on a Y-mount, you can setup both *robot parts* to use the same *end-effector* by creating one tool in the **AAA – Tools** node for each *robot part + end-effector* combination.

INFO / TIP

8.5.9 Sharing end-effectors between more Robot Programs and cobots

You can share *end-effector* setups between more Robot Programs and cobots by maintaining a Robot Program template that holds all your *end-effectors* setups in a **AAA – Tools** node acting as a database that you can copy between Robot Programs and cobots. This will be a good idea if you have several *end-effectors* that you deploy in several applications.

8.6 Programming tool change on other cobots



TIP! There is valuable information and inspiration to be found for robot programming in chapter **8.5 Programming tool change on Universal Robots cobots** even though you are not using a cobot from Universal Robots.



ATTENTION! The required *robot limits* explained in chapter **9** Safety must be setup not only for safety reasons but also to limit the cobot's strength to prevent damage to the levers in the tool changer.


WARNING! You must read, understand and fully comply with all the requirements in chapter **9** Safety before commencing cobot motion. Failing in doing so can cause serious injury and even death.

WARNING! Programming automatic tool change must always be conducted as per instructed in chapter **8.4 Good practice for setting up tool changes**.

WARNING! To reduce risk of hardware damage and human injury, always test tool changes thoroughly at low cobot speed and in a controlled and safe test environment before deploying in production.

WARNING! Programming the cobot movement without the *pass-through modules* installed is important to prevent unintended movement of *end-effectors* which can pose a risk to human health and to prevent hardware damage.

WARNING Energy (electricity, vacuum, air pressure) to a pass-through module must be turned off and any residual electricity, air pressure, vacuum etc. in the system must be eliminated before tool change takes place. Failing in doing so will result in hardware damage and can result in injury.



The WINGMAN Tool Changer System can be deployed in combination with all cobots that comply with the safety requirements found in chapter **9** Safety and which are able to move in two axis or more.

- Step 1. Install the tool part + end-effector assemblies in the tool part holders you will be deploying.
- Step 2. Program waypoint W2. For details about waypoints and cobot movement please visit chapter 8.1 Important about waypoints.
- Step 3. Program waypoint W1 which is a straight movement aligned with the *robot part* Z-axis relative to waypoint W2.
- Step 4. Program waypoint W4 which is a straight movement radial to the *robot part* Z-axis relative to waypoint W2.
- Step 5. Investigate how your *cobot* automatically can toggle between parameters for the deployed *end-effectors* and incorporate this toggle in Waypoint W4.



9 Safety

9.1 Limitation of liability:

All information provided in this user guide may not be perceived as a warranty by TripleA Robotics ApS that this industrial part-machine cannot cause personal injury or property damage, even if all safety instructions and parameters are complied with.

9.2 Responsibility of the System Integrator

The WINGMAN Tool Changer System is categorized as a *partly completed machine* according to *the Machine Directive 2006/42/EC* and it is therefore the responsibility of the *system integrator,* who installs and deploys the WINGMAN Tool Changer System, to ensure that:

- installation guidelines and other instructions in this user guide are followed in full and
- a risk assessment is completed and documented for the full robot application and
- test that the tool change process performs with high level of reliability.
- that the full robot application is safety approved before deployment.
- that users have received the proper training to operate the application safely.

Among other, the *system integrator's* risk assessment must include *end-effector* and *cobot* movement to and from the *tool space* (see chapter 9.5 The Tool Space) and inside the *tool space* while tool change is executed between waypoint W1 and W4 (see chapter 8.1 Important about waypoints). And the *System Integrator* must:

- deploy and maintain the *Pre-deployment Checklist* provided in chapter 9.8.1 Pre-deployment checklist and residual risks and
- deploy and maintain the *Startup Checklist* provided in chapter 9.8.2 Startup checklist.



WARNING! The System Integrators failure to complying with his responsibilities can result in hardware damage, serious injury and even death.

9.3 Responsibility of the user

The user must:

- follow the instructions provided in this user guide and
- follow the instructions provided by the system integrator and
- never put limbs inside the tool space while the robot application is active and
- deploy and maintain the *Startup Checklist* provided in chapter 9.8.2 Startup checklist and
- deploy and maintain the Interval Checklist provided in chapter 9.8.3 Interval checklist.



WARNING! Failing in complying with above requirements can result in hardware damage, serious injury and even death.



9.4 Main hazards

The main hazards related to automatic tool changes deployed using the WINGMAN Tool Changer System are:

1. A user receiving *quasi-static contact* as the cobot moves the *robot part* towards the *tool part holder*.



2. A user receiving *quasi-static contact* as the cobot moves the end-effector towards the *tool part holder*.




The above two main hazard can be reduced by complying with the content of chapter 9 Safety and warnings in this user guide.



9.5 The tool space

The *tool space* is defined by a distance of 50 mm to any part of a *tool part holder* and *tool part* installed in a *tool part holder*. The *tool space* is **NOT** part of the *collaborative workspace* where the cobot intentionally interacts with humans in a shared space. However, a set of *robot limits*, ensuring *collaborative safety*, apply inside the *tool space*. Even though *robot limits* apply in the *tool space*, the user is **NOT** allowed to access the *tool space* as the *robot application* runs.

Instructions for a suitable tool space placement are provided in chapter 6.6 Installing the tool part holder.



The settings provided in chapter **9.7 Load limiting and collaborative safety settings** apply for the *tool space* while another set of collaborative safety setting can be required for the *collaborative workspace* which is determined by the *system integrator's* risk assessment.



ATTENTION! High tool change speeds will increase wear and increase risk hardware damage in case that tool change is prevented.

WARNING! Users and spectators have no reason and are not allowed to put limbs into the *tool space* whilst the robot application is running. Doing so may result in injury.

WARNING! It is the *system integrators* risk assessment that determines how the cobot can move safely to and from the *tool space* and inside the *tool space* among other at what speed the cobot is allowed to move to ensure users time to move limbs free from moving parts.

9.6 Cobot requirements

If the WINGMAN Tool Changer System is deployed in *collaborative operation*, the cobot, that the WINGMAN Tool Changer System is installed onto, must comply with standard EN ISO 10218-1:2012 section *5.10 collaborative operation requirements*.



DANGER

TIP for Universal Robots users: All *cobots* from Universal Robots are certified to standard EN ISO 10218-1:2012 section *5.10 collaborative operation requirement.*

WARNING! Deploying the WINGMAN Tool Changer System in *collaborative operation* on a robot that is not certified for collaborative operation as per EN ISO 10228-1:2012 can result in hardware damage, serious injury and even death.

9.7 Load limiting and collaborative safety settings



ATTENTION! Even if the *tool space* is inaccessible for the user, e.g. behind safety guards, the collaborative safety settings (*robot limits / load limits*) must still be setup accordingly to prevent overload and hardware damage to the levers inside the *tool part*.

WARNING! The URcap software provided by TripleA robotics does **NOT** provide the mandatory collaborative safety settings (*robot limits*) for cobot movement inside or outside the *tool space*. Instead these must be setup manually by the *system integrator*.

Required collaborative safety settings e.g. *robot limits* (load limits) and maximum cobot speed must be evaluated and determined in the *System Integrators* risk assessment and the *System Integrator* must ensure these are setup correctly in the cobot's software before deployed the *robot application* into production.

In terms of *quasistatic contact* **NOT** considering any other parts in the *robot application* besides the three tool changer parts being the *robot part*, the *tool part* and the *tool part holder*, a maximum *quasistatic contact* between the three said parts of up to 100N can be permitted within the framework given in standard ISO/TS 15066.

In terms of preventing hardware damage to the levers inside the *tool part*, a maximum allowed force generated on the cobots tool flange of 100N is allowed.

The cobot's maximum allowed speed inside and outside the *tool space* must be part of the *System Integrators* risk assessment to ensure that users and spectators are able to predict the cobot's movement and have time to remove limbs before quasi-static contact can occur on users and spectators limbs.

9.8 Checklists, risk reduction and residual risks

This chapter contains three checklists to help understand the *residual risk* and promote collaborative safety whilst installing and using the WINGMAN Tool Changer System in *collaborative operation*. The *residual risk* must be observed and accepted in the *system integrator's* risk assessment and by the user.

If the *system integrator* or user cannot accept the *residual risk* associated with *collaborative operation*, the WINGMAN Tool Changer System may not be deployed in the robot application in question before the *system integrator* has deployed own initiatives to bring down the *residual risk* to a level that can be accepted by the *system integrator* and the user.

9.8.1 Pre-deployment checklist and residual risk

To ensure that the WINGMAN Tool Changer System can be deployed in *collaborative operation*, all risk reducing requirements throughout this user guide must be observed and complied with by the *system integrator* and by the user. In beneath a checklist is provided that summarize the most important risk reducing requirements and explain associated *residual risks*.



WARNING! The *system integrator* and user must among other observe and comply with the "PRE-DEPLOYMENT CHECKLIST AND RESIDUAL RISKS" before the robot application is deployed.

WARNING! All though all safety requirements in this user guide have been complied with, a user can receive *quasi-static contact* which can cause injury.

9.9 ID tag system

It is important to prevent a scenario where the cobot collects an incorrect *end-effector* which can happen, if the user has placed an *end-effector* in a wrong *tool part holder*. To prevent this scenario, it must be possible for the user to determine what *end-effectors* goes with what *tool part holder* with use of a simple ID tag system.

The System Integrator must deploy an ID tagging system, e.g. stickers with matching numbers, to allow users to match *end-effectors* and *tool part holders* together in order

9.10 Warning signs

The system integrator must ensure that warning signs are visible for users and spectators. The warning signs must warn users and spectators that the *tool space* area poses a pinch points hazard (quasi-static contact) and that users and spectators are not allowed to put their limps into the *tool space* area. The warning sign used should be beneath or equivalent (not provided by TripleA robotics).



10 Repair and maintenance

10.1 Life span and maintenance

The WINGMAN Tool Changer System requires maintenance to an extend determined by the conditions of use and the surrounding environment.

The life span of the WINGMAN Tool Changer System is determined by a combination of the:

- external environment (clean or dirty)
- tool change parameters (e.g. couple load, waypoint accuracy, ICoG, cobot speed)
- maintenance (cleaning and lubing intervals)



WARNING! Deploying the WINGMAN Tool Changer System in a dirty environment is only allowed if tool change is reliable and stable and does not require frequent intervention by the user. Unstable tool change can temp users to intervein in tool change while the cobot moves which can cause injury.

10.1.1 Wear

Wear will be visible over time, as the tool changer is being used. Typical normal and expected wear is the grey surface treatment wearing off in the areas where tool changer parts are engaging/disengaging with each other. Wear will result in small deposits of very fine oxides and polymers that can easily be removed with compressed air and cloth.

The WINGMAN Tool Changer System takes a significant number of tool change cycles to wear in. As this process takes place, tool changes can in some cases be a little rough running and produce more oxides and polymers deposits then will be the case after the wearing in process has completed.

When a tool changer part is worn to the extend where the aluminum beneath the surface treatment is exposed, the tool changer part is worn out and must be replaced. Such wear and tear is normal and expected and is not covered by warranty even though a tool changer part wears out within the warranty period.

10.1.2 Cleaning

Cleaning will be necessary with intervals that depends on the conditions of use.

Cleaning is done using compressed air and cloth and a cleaning spray suitable for alloys and polymers can be used. Normally, cleaning of the *tool parts* internal mechanical parts will only be necessary rarely if at all and is done by disassembling the *tool part* and cleaning and lubing the insides.

Cleaning electrical connectors must be done with isopropyl alcohol and a cotton swab.




ATTENTION! Disassembling the *tool part* for cleaning will depreciate the warranty on your product.




10.1.3 Lubing the tool changer

The *tool part* comes pre-lubricated and will not need lubrication until a cleaning process is performed. After cleaning, the beneath places should be re-lubricated with a **silicone-based grease** suitable for metal alloys and polymers applied in a thin layer



The *tool part holder* does not come pre-lubricated. Lubrication of the *tool part holder* is optional but will be necessary to achieve long life span and smooth tool change. After cleaning, the beneath places should be re-lubricated with a **silicone-based grease** suitable for metal alloys and polymers applied in a VERY thin layer.



10.1.4 Lubing the pass-through modules

Occasionally, a little silicone-based grease must be applied on all rubber parts, such as O-rings and gaskets, on pass-through modules to ensure long lift span and prevent leaks.



10.2 Damage and repair

Mainly the levers are exposed to wear and possible damage if the tool changer is used incorrectly or in high stress tool change cycles (high speed, high tool change load, high ICoG).

The *tool part* can be disassembled, repaired, and reassembled in case of damage to the levers, springs or bearings inside.

Follow beneath guide to disassemble and reassemble the tool part.
